#### Features and benefits

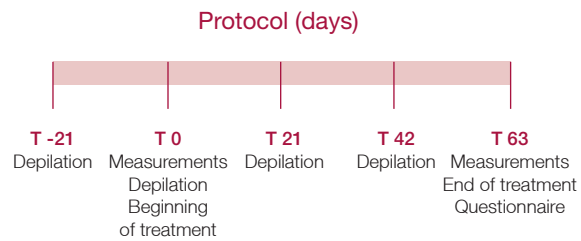
Selective inhibition by Telocapil of the tyrosine kinase activity of the IGF-1 receptor prevents follicular growth during the anagen phase.

## In Vivo

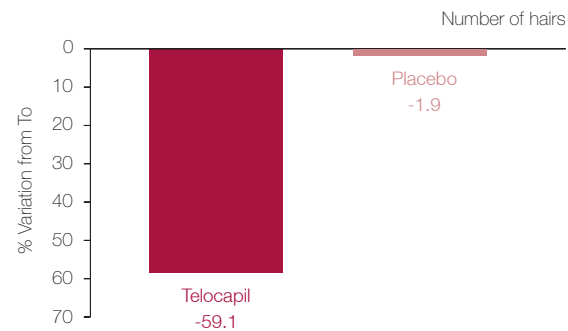
### In Vivo activity

The study involved 15 volunteers, who applied Telocapil 2% on one leg and Placebo on the other leg, twice daily, for 63 days. Measurements were taken every 21 days. Volunteers filled an evaluation questionnaire by the end of the treatment.



#### • Hairiness reduction

Hairs were counted in a 4cm<sup>2</sup> area, delimited within the application zone.



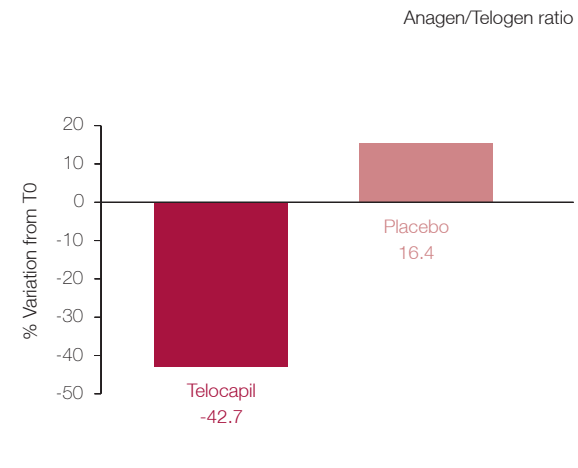
**Telocapil** reduced hairiness by about **60%** as compared to placebo.



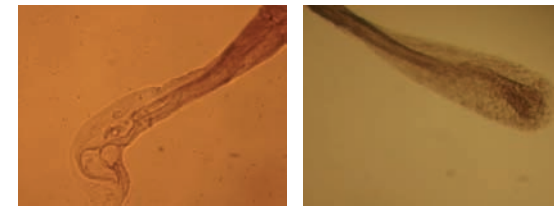

Telogen phase

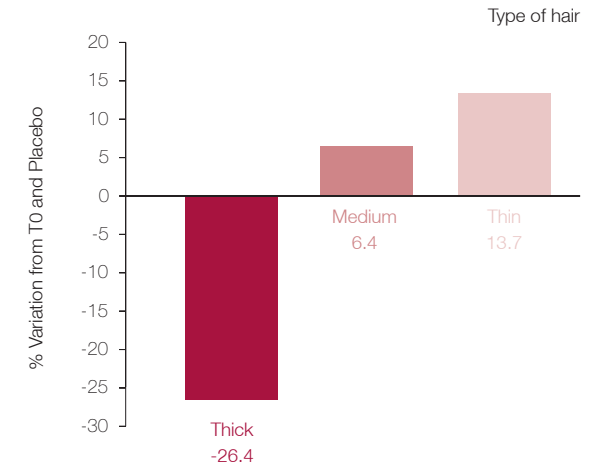
### Efficacy perception
